

#### **Weekly Finance Newsletters**

#### **CRP Preparation kits**

In a manner similar to the SIRP preparation kits, Caf-fin offers comprehensive preparation aids to the senior Finance batch gearing up for their CRP. These kits are meticulously crafted, encompassing theoretical concepts, past interview experiences, and common interview questions. This initiative aims to provide students with a thorough understanding and readiness for their CRP, significantly aiding them throughout their preparation process.

#### **Getting Industry Ready**

Caf-fin conducts various sessions/ events/ lectures in collaboration with the senior batches and alumni with a common aim and agenda of students preparing the corporate competitions, ensuring that the students are well aware of the projects undertaken and the manager's expectations, preparing them to manage specific projects and day-to-day chores. #### **Mock GD-PI Sessions**

Finance students were given extensive preparation for the Summer Internship Recruitment Program (SIRP) through mock Group Discussions (GDs) and Personal Interview (PI) sessions. These opportunities were designed to equip students with both the technical knowledge and soft skills essential for excelling in their summer internship interviews. The mock GDs and PIs simulated real interview scenarios, helping students build confidence, improve their communication abilities, and fine-tune their problem-solving techniques. This holistic approach ensured that students were well-prepared and poised to succeed in securing their desired internships.

#### Sample Interview Questions Kit

To provide students with a direct preview of the interview process, a comprehensive compendium of previous years' questions is distributed among the junior batch. This resource allows students to familiarize themselves with the types of questions likely to be asked during the Summer Internship Recruitment Process (SIRP). By reviewing these questions, students can tailor their preparation to the specific job roles offered by various recruiters. This targeted approach helps them focus on key topics and stay current with the requirements of specific positions.

# Finspire Lectures

In pursuit of preparing the junior batch for the upcoming summer internship process, Caf-Fin organized the Finspire Series, one of the most fruitful and successful SIRP preparatory activities. To help students keep pace with the demands of the Summer Internship process, Caf-Fin initiated the SEED series, featuring sessions led by seniors for the junior batch. 
## Corptune


