The term of the Chairperson and members of the Committee shall be of two years i.e., from 23rd February, 2026 to 22nd February, 2028.

The term of the special invitee shall be one-year i.e., from 23rd February, 2026 to 22nd February, 2027.

A member shall cease to be a member of the Campus Student Grievance Redressal Committee as soon as he/she ceases to belong to the category from which he/she became the member of the Committee.

The powers, functions & procedure to be followed for meeting(s) of the constituted Campus Student Grievance Redressal Committee at the Lavale Hill Top Campus/ Location of Symbiosis International (Deemed University), Pune shall in accordance with rules thereof and amended from time to time.
