### Following points were discussed during the meeting: -

1. Dr. V.V. Ravikumar, Dy. Director & Member-Teaching, in the absence of Director, SIBM Pune, Dr.R. Raman, chaired the meeting and welcomed all the members to the 2nd IQAC Meeting for the academic Year 2017-18. Minutes of the previous meeting were confirmed.
2. Status on action plan was discussed. Prof. Yogesh Brahmankar, Member-Teaching, discussed about initiatives like SymAccelerate & Integrated Live Project for students of MBA (I&E).
3. Members were briefed about training programme organized for faculty in respect of Centre for Monitoring Indian Economy (CMIE) prowess & Euromoney Information System (EMIS) software packages.
4. Dr. Ravikumar briefed about sensitization of faculty members & students towards quality research output and highlighted a joint publication between faculty and students in a Scopus indexed journal.
5. Focus on increasing number of consultancy assignment and revenue was reiterated and it was informed that SIBM, Pune has bagged three consultancy assignments from Nestle, Mother Dairy & Mahindra & Mahindra worth Rs. 15,00,000/-
6. It was informed to the members that there is likelihood of another MDP with a leading insurance company in pipeline.
7. Dr. C.R. Patil, Management Representative, suggested that for students of MBA (I&E), learning from other entrepreneur's failure stories could help in learning from & coping with adverse situations and results.
8. Mr. Jitendra Paturkar, Alumni Representative suggested that more branding and communication was required to connect with external stakeholders, especially alumni. For instance, alumni could be sent invitation for flagship events of SIBM Pune like Senate, Transcend etc.

9. Members were also briefed about strengthening collaboration initiative like faculty and students exchange programmes, inviting faculty from Foreign Universities to take full time course or part of the credit and enhancing learning processes. To quote a few examples
  - Prof. Pawan Budhwar, Professor (Aston Business School) taught International HRM – a two credit course to the MBA 2016-18 batch (Sem-IV).
  - Dr. Chinmoy Ghosh, Gladstein Professor (University of Connecticut) taught Investment Banking – a two credit course to MBA 2016-18 batch (Sem-III)
  - Dr. Prasanta Dey, Professor (Aston Business School, United Kingdom) taught Sectorial Studies in Supply Chain - a two credit course to MBA 2016-18 batch (Sem-III)
10. There was discussion on student satisfaction survey wherein it was agreed that feedback could be initiated by all the student councils. General satisfaction survey format to be made by seeking inputs from internal and external stakeholders. The Survey guidelines and format should be made by taking inputs from current batch of students and alumni from recent batches.
11. Some suggestions came up on how to ensure greater learning which were adequately responded to by Dr. Ravikumar.
12. Other points discussed were-
  - renovation of seating area for coordinators and office staff;
  - demonstration of smart boards for classrooms
  - successfully concluded HR Conclave, 2017; Senate 2018 towards learning, exchange of ideas, and greater industry connect.

There being no other matter for discussion, the meeting concluded with a vote of thanks to all present.
