Secondly, they offer a smart controller “Ecotron” for irrigation pumps which complements their offerings in the solar/agri-solutions space which is a major market shareholder. They are headquartered at Pune and have major operations at Raipur. They are also spread across other locations such as Hyderabad, Chandigarh & Delhi. Ecozen was selected by **Villgro Innovation Foundation** for their SEED program. Ecozen Solutions idea is among world’s top 30 business ideas at **Stanford’s E-boot camp**, they have also won **Dow Sustainability Innovation Challenge** at California Institute of Technology, Pasadena.
